TERMS AND CONDITIONS

CONFIRMATION OF BOOKING

IN ORDER TO SECURE A DATE/BOOKING, A CLEARED BOOKING FEE PAYABLE TO DISH CORNWALL LIMITED IS REQUIRED. ON OUR WRITTEN CONFIRMATION THAT YOUR BOOKING IS SECURED AND NUMBERS/PRICES/DATE AGREED, A CONTRACT BETWEEN US WILL BE FORMED ON THESE TERMS AND CONDITIONS AND YOU WILL BE FORMALLY BOUND BY THE PROVISIONS OF THESE TERMS AND CONDITIONS. PAYMENT OF YOUR BOOKING FEE CONFIRMS AGREEMENT TO THESE TERMS AND CONDITIONS.

CATERING SERVICES

WE WILL SUPPLY THE CATERING SERVICES FOR THE EVENT ON THE DATE/S SET OUT IN OUR CONFIRMATION OF BOOKING. PAYMENTS ARE REQUIRED AT THE TIMES STATED IN THIS CONTRACT. PLEASE SEE OUR PRICING STRUCTURE FOR MORE DETAILS.

WE SHALL PROVIDE THE CATERING SERVICES:

- IN ACCORDANCE WITH FOOD CATERING INDUSTRY STANDARDS FOR HYGIENE AND GENERAL CLEANLINESS CONCERNING:
 - THE PREPARATION AND COOKING OF FOOD
 - THE HANDLING AND SERVICE OF FOOD, BEVERAGES, UTENSILS AND TABLEWARE
- IN COMPLIANCE WITH STATUTORY AND REGULATORY REQUIREMENTS AFFECTING THE PREPARATION, COOKING, HANDLING AND SERVICE OF FOOD.

PRICES QUOTED AND GUEST NUMBERS

PRICES QUOTED ARE VALID FOR THE NUMBER OF GUESTS ATTENDING IN THE WRITTEN QUOTATION TO YOU. AN INCREASE OR DECREASE IN THE PROSPECTIVE OR ACTUAL NUMBERS ATTENDING YOUR EVENT MAY AFFECT THE FINAL INVOICE AMOUNT DEPENDING ON ADDITIONAL EQUIPMENT / SERVICES REQUIRED.

PRICES AND QUOTATIONS FOR WEDDING CATERING (MARKET VALUE FOOD COSTS) AND OUR SERVICES (INCLUDING SUPPLIERS, EQUIPMENT, STAFF HIRE/ AGENCIES/FUEL INCLUDED IN OUR PACKAGE/RATES) ARE SUBJECT TO CHANGES SHOULD THERE BE AN INCREASE BETWEEN THE TIME OF YOUR WEDDING/ EVENT BOOKING CONFIRMATION AND YOUR WEDDING/EVENT DATE. THIS IS SIMPLY DUE TO RISES OUT OF OUR CONTROL.

PLEASE NOTE THAT OTHER CONTRACTORS THAT ARE NOT LINKED TO DISH CORNWALL LIMITED ARE NOT ENTITLED TO A MEAL. IF MEALS ARE REQUIRED FOR SUCH CONTRACTORS SUCH AS PHOTOGRAPHERS, BABYSITTERS, BAND MEMBERS, MUSICIANS, AND SO ON, THESE WILL BE CHARGED AT £20.00 PER HEAD AND WILL CONSIST OF ONE MAIN MEAL/PLATE OF FOOD. WE CANNOT CATER FOR DIETARY REQUIREMENTS IN THIS INSTANCE WITHOUT PRIOR NOTICE.

PAYMENT STRUCTURE

YOUR BOOKING FEE QUOTED COVERS THE COST OF THE ADMINISTRATIVE AND COMMUNICATION SERVICES INVOLVED WITH CREATING YOUR WEDDING BOOKING PROFILE, AS WELL AS A 2 HOUR PLANNING MEETING WITH DISH CORNWALL TO DISCUSS YOUR WEDDING AND CREATE A RUNNING ORDER FOR YOUR WEDDING DAY.

IN ADDITION TO THE BOOKING FEE PAYMENT IS THE COST PER PERSON / COST OF THE WEDDING PACKAGE.

FINAL FULL PAYMENT (CLEARED FUNDS) WILL BE REQUIRED 6 WEEKS PRIOR TO THE EVENT TAKING PLACE. THIS PAYMENT WILL BE BASED ON THE NUMBER OF GUESTS CONFIRMED AT THIS TIME. WE WILL HOWEVER ENDEAVOUR TO ACCOMMODATE ANY LAST MINUTE ADDITIONS NOTIFIED AFTER WE HAVE RECEIVED YOUR BALANCE PAYMENT. ANY ADDITIONAL EXPENSES SUCH AS AN INCREASE IN NUMBERS, STAFFING OR ADDITIONAL EQUIPMENT REQUIRED WILL BE INVOICED AND PAYABLE PRIOR TO THE EVENT DATE. REDUCTIONS IN GUEST NUMBERS WILL NOT BE REFUNDED.

A REFUNDABLE DEPOSIT PAYMENT OF £200.00 IS ALSO REQUIRED AT THIS STAGE AND WILL BE HIGHLIGHTED ON YOUR INVOICE IF YOU ARE HIRING CATERING EQUIPMENT SUCH AS CROCKERY, CUTLERY, GLASSWARE, AND KITCHEN EQUIPMENT THROUGH DISH CORNWALL LIMITED. THIS WILL BE REFUNDED TO YOU AFTER YOUR EVENT DATE MINUS ANY DAMAGES AND BREAKAGES (AND GAS IF APPLICABLE) THAT MAY OCCUR DURING THE EVENT THROUGH FAULT NOT OF OUR OWN. IF YOU WILL NOT BE CONTACTABLE AFTER YOUR WEDDING DAY (I.E. YOU ARE ON YOUR HONEYMOON,) PLEASE ENSURE WE HAVE YOUR BANK DETAILS BEFORE YOUR WEDDING SO THIS PAYMENT CAN BE MADE BACK TO YOU WITHOUT DELAY.

A FINAL RUNNING ORDER WILL BE FORWARDED FOR COMPLETION 3 MONTHS PRIOR OF THE EVENT, REQUESTING ANY AMENDMENT OF FINAL NUMBERS, DIETARY REQUIREMENTS AND CONFIRMATION OF THE SERVICES WE ARE PROVIDING. WE ASK YOU TO COMPLETE AND RETURN THIS RUNNING ORDER TO US. IF WE RECEIVE THE AMENDED RUNNING ORDER ANY LATER THAN 4 WEEKS PRIOR TO THE EVENT, WE MAY NOT BE ABLE TO PROVIDE THE SERVICES IN FULL. IF SO, WE WILL NOT BE LIABLE FOR ANY FAILURE TO PERFORM THE SERVICES IN FULL ARISING AS A RESULT OF YOUR DELAY IN RETURNING THE RUNNING ORDER TO US.

FINAL NUMBER OF GUESTS MUST BE CONFIRMED IN WRITING (RUNNING ORDER AND/OR E-MAIL) A MINIMUM OF 6 WEEKS PRIOR TO THE EVENT TAKING PLACE. THE NUMBER OF GUESTS CONFIRMED AT THIS TIME WILL BE THE MINIMUM NUMBER OF GUESTS THAT YOU WILL BE CHARGED FOR. WE WILL MAKE EVERY EFFORT TO ACCOMMODATE REQUESTS FOR AN INCREASE IN NUMBERS AT SHORT NOTICE.

CANCELLATION OF BOOKING

SHOULD YOU DECIDE TO CANCEL THE BOOKING SUBSEQUENT TO PAYING A BOOKING FEE TO SECURE YOUR DATE, NO MONEY WILL BE RETURNED REGARDLESS OF THE REASONS YOU DECIDE TO CANCEL THE BOOKING.

SUBSEQUENT TO YOU PAYING A BOOKING FEE, SHOULD YOU DECIDE TO CANCEL THE BOOKING FOR ANY REASON WHATSOEVER, LESS THAN 3 MONTHS PRIOR TO THE PLANNED EVENT DATE, PAYMENTS TOTALLING 50% OF THE INVOICE TOTAL MUST BE PAID. FOR CANCELLATION WITHIN 4 WEEKS UP TO THE DAY OF THE EVENT, 100% OF THE BALANCE IS PAYABLE AND NON-REFUNDABLE, REGARDLESS OF THE REASON FOR CANCELLATION.

WE REQUEST THAT YOU TAKE OUT EVENT INSURANCE TO COVER YOUR COSTS IF YOU NEED TO CANCEL THE BOOKING OR ARE UNABLE TO MAKE THE EVENT ON THE DAY FOR ANY REASON.

STAFFING AND STAFF COSTS

THE PRICE THAT YOU HAVE BEEN QUOTED FOR YOUR PARTICULAR EVENT **MAY** INCLUDE THE COST OF STAFF AS SPECIFIED. HOWEVER, YOUR ATTENTION IS DRAWN TO THE FOLLOWING: WE WILL AGREE WITH YOU A PLANNED DINING TIME WHICH INCLUDES A DEGREE OF FLEXIBILITY, IN AS MUCH AS WE ARE PLEASED TO ACCOMMODATE A LATER STARTING TIME OF UP TO HALF AN HOUR FROM THE ORIGINAL AGREED START TIME. ANY LATER START TIME WILL ENCOUNTER STAFFING COSTS OF £25.00 PER HOUR OR PART HOUR PER MEMBER OF STAFF ON DUTY.

WEDDING PACKAGES, ANTICIPATING STARTER, MAIN COURSE, DESSERT AND COFFEE TOGETHER WITH CHAMPAGNE TOAST AND CAKE CUTTING, ARE CALCULATED ON THE BASIS OF A COMPLETE PERIOD OF TWO AND A HALF HOURS FROM THE AGREED 'SIT- DOWN' TIME TO THE START OF TABLE CLEARANCE, INCLUDING SPEECHES. ANY EXTENSION OF THIS TIME WILL ENCOUNTER STAFFING COSTS OF £25.00 PER HOUR OR PART HOUR PER MEMBER OF STAFF ON DUTY. THIS IS SIMPLY THE COST OF ADDITIONAL STAFFING TIME, INCLUDING BUT NOT LIMITED TO, AN OCCASION WHEN A CLIENT BOOKS AN EVENT TO START AT 5PM, AND IN THE FINAL ANALYSIS DOES NOT START UNTIL 7PM, PERHAPS WHERE PHOTOGRAPHS RUN ON, OR WITH VERY LONG SPEECHES WHICH CONTAIN SLIDE SHOWS OR VIDEOS. IN THESE INSTANCES, THE WHOLE PERIOD OF FOODSERVICE IS EXTENDED BEYOND OUR CONTROL AND PLANNED COSTS. THIS WILL BE INVOICED TO YOU WITHIN 7 DAYS AFTER THE EVENT.

HEALTH AND SAFETY

DISH CORNWALL LIMITED HAVE THE RESPONSIBILITY OF THE SAFETY AND WELL-BEING OF OUR TEAM OF STAFF WHILST WORKING. YOUR CHOSEN VENUE (INCLUDING MARQUEE SITES) MUST, IN LINE WITH THE HEALTH AND SAFETY AT WORK ACT 1974 BE SAFE FOR WORK, INCLUDING A WATER SUPPLY THAT IS NOT CONTAMINATED, SAFE AND EVEN FLOORING WHERE STAFF ARE EXPECTED TO WORK AND SERVE FROM, SUFFICIENT AND SAFE ELECTRICITY SUPPLY INCLUDING SUFFICIENT LIGHTING IN FOOD PREPARATION AREAS, AREAS FOR LOADING/UNLOADING EQUIPMENT AND CONSUMABLES NEXT TO THE VENUE/MARQUEE AND SECURE PARKING FOR STAFF.

INAPPROPRIATE LANGUAGE AND BEHAVIOUR FROM GUESTS WILL NOT BE TOLERATED BY DISH CORNWALL LIMITED AND MAY RESULT IN OUR TEAM LEAVING THE VENUE EARLY WITHOUT COMPLETION OF SERVICES SHOULD A STAFF MEMBER HAVE BEEN TREATED IN AN INAPPROPRIATE OR DISRESPECTFUL MANNER BY GUESTS/CLIENTS. WE ADVISE YOU TO HIRE A SECURITY TEAM FOR EVENTS WHERE GUESTS ARE OF A LARGE NUMBER (100+) AND ALCOHOL IS BEING CONSUMED. DISH CORNWALL LIMITED ARE NOT ACCOUNTABLE FOR CROWD CONTROL.

DISH CORNWALL LIMITED HAVE TEAM MEMBERS QUALIFIED IN BASIC FIRST AID AT WORK. WE ARE NOT HOWEVER QUALIFIED TO CARRY OUT FIRST AID ON CLIENTS OR GUESTS. PLEASE ENSURE YOU CHECK WITH YOUR VENUE/EVENT PLANNER THAT THERE WILL BE A FIRST AIDER AVAILABLE SHOULD A SITUATION OCCUR AMONGST YOUR GUESTS AND/OR OTHER SUPPLIERS.

FOOD SAFETY

PLEASE NOTE, IT IS OUR STANDARD PRACTISE TO REMOVE ALL LEFTOVER FOOD FROM SITE, UNLESS BY SPECIFIC AND PRIOR SIGNED AGREEMENT. THIS IS IN THE INTEREST OF FOOD SAFETY, AND ONCE WE ARE OFF SITE WE CAN HAVE NO CONTROL OVER THE SAFE STORAGE OF LEFTOVER FOODSTUFFS, AND THEREFORE WILL HAVE NO LIABILITY FOR ANY CONSEQUENTIAL INCIDENCES OF FOOD POISONING OR OTHER INCIDENCES.

DIETARY REQUIREMENTS/ALLERGIES

THESE MUST BE SPECIFIED IN YOUR RUNNING ORDER AND WE WILL ADHERE TO YOUR INSTRUCTIONS. GUESTS WITH SAID REQUIREMENTS MUST BE HIGHLIGHTED ON YOUR TABLE PLAN AND THE INDIVIDUAL(S) MUST MAKE THEMSELVES AWARE TO OUR FRONT OF HOUSE MANAGER BEFORE FOOD SERVICE COMMENCES. PLEASE COMMUNICATE THIS WITH YOUR GUESTS.

DISH CORNWALL LIMITED WILL TAKE EVERY CARE AND CONSIDERATION IN THE PREPARATION OF FOOD AVOIDING SPECIFIED INGREDIENTS, HOWEVER IT IS YOUR DUTY TO ENSURE THE VENUE AND OTHER FOOD SUPPLIERS SUCH AS CAKE/EDIBLE WEDDING FAVOURS/BAR STAFF ARE AWARE OF THESE REQUIREMENTS, AS WELL AS ENSURING THE VENUE CARRY OUT A DEEP-CLEAN OF THE KITCHEN FACILITIES TO REMOVE TRACES OF INGREDIENTS THAT MAY CAUSE ALLERGIC REACTIONS.

WE WORK WITHIN STRICT GUIDELINES (SAFER FOOD BETTER BUSINESS, ENFORCED BY CORNWALL COUNTY COUNCIL) BUT WE CANNOT ELIMINATE 100% OF ALLERGENS FROM DISHES AND WE CANNOT GUARANTEE THAT OUR FOOD WILL BE 100% ALLERGEN FREE, AS OUR PREPARATION KITCHEN WILL CONTAIN

INGREDIENTS IN THE ATMOSPHERE WHICH MAY CAUSE HARM TO PEOPLE. PLEASE MAKE ANY GUESTS YOU HAVE WITH ALLERGIES AWARE OF THIS PRIOR TO YOUR WEDDING DAY.

CHILDREN

IF CHILDREN ARE TO BE PRESENT AT THE EVENT, YOU SHOULD ENSURE THAT THERE ARE A SUFFICIENT NUMBER OF ADULTS PRESENT TO PROPERLY SUPERVISE THEM AND TAKE CARE OF THEM. YOU ACKNOWLEDGE THAT CHILDCARE IS NOT THE RESPONSIBILITY OF DISH CORNWALL LIMITED.

SUPPLY OF BARS AND ALCOHOL (IF APPLICABLE)

PLEASE BE AWARE THAT IN ACCORDANCE WITH THE LOCAL LICENSING AUTHORITY, DISH CORNWALL LIMITED STAFF ARE TRAINED TO IMPLEMENT THE CHALLENGE 21 POLICY, WHEREBY GUESTS OVER THE AGE OF 18 BUT APPEAR TO LOOK UNDER 21 WILL BE REQUIRED TO SHOW PHOTO ID IF REQUESTED BY OUR STAFF. PLEASE NOTE, THE 'CHALLENGE' IS ENTIRELY AT OUR DISCRETION AND ANY GUESTS WHO CANNOT PRODUCE THE REQUIRED ID ON REQUEST WILL NOT BE SERVED. WE THANK YOU FOR UNDERSTANDING AND CO-OPERATION IN THIS MATTER. WE DO NOT ALLOW BAR TABS TO BE RUN. ALL ALCOHOL MUST BE PRE-PAID, OR PURCHASES OF DRINKS PAID BY THE INDIVIDUAL BY CASH OR BANK CARD AT THE POINT OF SERVICE.

RUBBISH AND WASTE REMOVAL

IT IS OUR STANDARD PRACTICE TO REMOVE ANY FOOD WASTE AND FOOD PACKAGING FROM SITE CREATED BY DISH CORNWALL LIMITED. EMPTY BOTTLES/ CANS RESULTING FROM BAR SALES AND CLIENTS' OWN PURCHASE OF DRINKS, AS WELL AS WASTE FROM THE WEDDING TABLES, SUCH AS PAPER NAPKINS, STATIONERY, DECORATIONS, WRAPPINGS FROM GIFTS/FAVOURS, WILL NOT BE REMOVED FROM SITE BY DISH CORNWALL UNLESS SPECIFICALLY AGREED BEFOREHAND. ANY ADDITIONAL WASTE REMOVAL WILL BE CHARGEABLE PENDING THE QUANTITIES INVOLVED AND MUST BE PRE-ARRANGED. PLEASE ENSURE THERE ARE SUFFICIENT WASTE AND RECYCLING FACILITIES IN PLACE AT THE VENUE.

WEDDING CAKES

WE ARE PLEASED TO SET-UP YOUR CAKE (WITH PRECISE INSTRUCTIONS), PORTION THE CAKE, AND DISTRIBUTE IT TO YOUR GUESTS AS AGREED IN OUR RUNNING ORDER PROVIDING WE ARE ON SITE IN LINE WITH AGREED TIMINGS. THE EFFORTS THAT WE MAKE IN THIS RESPECT ARE THOSE OF GOODWILL AND THEREFORE CANNOT ACCEPT ANY LIABILITY AS TO THE TRANSPORTATION OF THE CAKE, THE SET-UP/STABILITY OF THE CAKE, AND THE CONSISTENCY OF THE CAKE, MORE SPECIFICALLY, HOW IT CUTS. PAPER NAPKINS MUST BE PROVIDED FOR THE DISTRIBUTION OF THE CAKE BY YOURSELVES. IF PLATES OR ALTERNATIVE TABLEWARE IS DESIRED, THIS MUST BE PRE-AGREED AND CHARGED FOR ACCORDINGLY, AS WELL AS GARNISH AND DESIRED ACCOMPANIMENTS.

SPILLAGES

IN THE EVENT OF ANY SPILLAGES OF FOOD OR DRINK EITHER DIRECTLY OR INDIRECTLY BY OUR STAFF CAUSING MARKING OR STAINING TO ANY GARMENT WORN BY YOUR GUESTS, WE WILL BE PLEASED TO COVER ANY DRY CLEANING CHARGES PAID OUT BY YOUR GUESTS TO CLEAN SAID GARMENTS. HOWEVER, IN THE EVENT THAT DRY CLEANING IS NOT SUFFICIENT TO REMOVE ANY PERMANENT STAINING, WE CANNOT UNDER ANY CIRCUMSTANCES BE HELD

RESPONSIBLE FOR THE REPLACEMENT OF GARMENTS AND WOULD RESPECTFULLY SUGGEST THAT THIS IS CLAIMED FOR ON THE INDIVIDUAL'S HOUSEHOLD INSURANCE.

EQUIPMENT COLLECTION

WHENEVER POSSIBLE, IT WILL BE AGREED PRIOR TO THE EVENT THAT ITEMS OF EQUIPMENT E.G. CROCKERY/CUTLERY, GLASSWARE, TABLEWARE, LINEN TABLE CLOTHS, LINEN NAPKINS, LARGE KITCHEN EQUIPMENT, ETC MAY BE LEFT ON SITE AFTER OUR STAFF HAVE LEFT, TO BE COLLECTED IN THE FOLLOWING DAYS. A COLLECTION CHARGE WILL APPLY WHICH MAY BE COSTED INTO THE ORIGINAL QUOTATION. IF, DURING THE FUNCTION, IT IS A CLIENTS' EXPRESS WISH THAT ITEMS OF EQUIPMENT REMAIN, OR THROUGH NO FAULT OF OUR OWN, HEAVIER ITEMS OF EQUIPMENT CANNOT BE REMOVED FOR SAFETY REASONS, A COLLECTION CHARGE WILL BE MADE AND INVOICED WITHIN 7 DAYS AFTER THE EVENT. EQUIPMENT CAN BE RETURNED TO OUR PREMISES FREE OF CHARGE.

BARBECUES, PAELLA AND WOOD FIRED EQUIPMENT

WITH PRIOR NOTICE, WE CAN TAKE PRECAUTIONS AGAINST POSSIBLE OIL/GREASE MARKS ON PATIOS AND DECKING AREAS BY USING MATTING. HOWEVER, IT SHOULD BE NOTED THAT WE CANNOT ACCEPT LIABILITY FOR ANY DAMAGE CAUSED.

LIABILITY AND INDEMNITY - LIMITATION ON OUR LIABILITY TO YOU

OUR LIABILITY TO COMPENSATE YOU FOR ANY LOSS OR DAMAGE (IN THE CASE OF LOSS OR DAMAGE OTHER THAN DEATH OR PERSONAL INJURY) IS LIMITED TO A REASONABLE AMOUNT, HAVING REGARD TO SUCH FACTORS AS WHETHER THE DAMAGE WAS DUE TO A NEGLIGENT ACT OR OMISSION BY US. IN NO EVENT SHALL OUR LIABILITY (EXCEPT IN THE CASE OF DEATH OR PERSONAL INJURY CAUSED BY OUR NEGLIGENCE) EXCEED THE GREATER OF £5,000,000 OR THE SUMS PAID BY YOU UNDER THIS CONTRACT. LIMITATION AND EXCLUSION OF LIABILITY FOR PERSONAL INJURY AND DEATH.

SUB-CONTRACTING

WE CAN ALLOW OTHERS (EITHER IN OUR PLACE OR TOGETHER WITH US) TO PROVIDE THE CATERING SERVICES. IF OTHER PERSONS PERFORM THE CATERING SERVICES WE WILL CONTINUE TO BE RESPONSIBLE FOR THE PERFORMANCE OF THE CATERING SERVICES AND OUR OBLIGATIONS UNDER THIS CONTRACT.

CONTACTING EACH OTHER

IF YOU WISH TO SEND US ANY NOTICE OR LETTER THEN YOU SHOULD SEND IT TO 44 TOR ROAD (UNIT 1) NEWQUAY, CORNWALL, TR7 1RL MARKED FOR THE ATTENTION OF MARK DEVONSHIRE - DISH CORNWALL. IF WE WISH TO SEND YOU A LETTER OR NOTICE, WE SHALL USE THE EMAIL ADDRESS USED FOR COMMUNICATION.

POINT OF CONTACT ON DAY OF EVENT

IN OUR RUNNING ORDER, WE ASK FOR A PERSON OF WHOM TO BE RESPONSIBLE ON THE DAY OF THE EVENT SHOULD YOURSELVES NOT BE ABLE TO BE CONTACTED OR DISTURBED. PLEASE ENSURE THIS PERSON IS MADE AWARE OF THIS AND INTRODUCES THEMSELVES TO MARK DEVONSHIRE OR THE FRONT OF HOUSE MANAGER BEFORE FOOD SERVICE COMMENCES.

FORCE MAJEURE

WE SHALL NOT HAVE ANY LIABILITY TO YOU UNDER THIS CONTRACT OR BE DEEMED TO BE IN BREACH OF IT FOR ANY DELAYS OR FAILURES IN PERFORMANCE WHICH RESULT FROM CIRCUMSTANCES BEYOND OUR REASONABLE CONTROL INCLUDING BAD WEATHER, INTERRUPTIONS TO POWER SUPPLIES, ACTS OF GOD, TERRORIST ACTIVITIES, FIRE, EPIDEMIC, CIVIL DISTURBANCE, NATURAL DISASTER, GOVERNMENTAL OR REGULATORY ACTION, AND SIMILAR EVENTS OUTSIDE OUR REASONABLE CONTROL.
